

Vantage15 - Subscription Terms

Effective Date: June 29, 2026

These Subscription Terms govern the purchase, billing, renewal, and cancellation of paid subscriptions to the Vantage15 application ("Vantage15," "the app," "the service") provided by Keystone Masterworks, LLC ("we," "us," or "our"). These Subscription Terms supplement and are incorporated into the Vantage15 Terms and Conditions. By starting a free trial or purchasing a subscription, you agree to these Subscription Terms. Where these terms conflict with the general Terms and Conditions on subscription matters, these Subscription Terms control.

1. SUBSCRIPTION TIERS

Vantage15 offers a free tier and two paid tiers. Paid features and pricing may change as described in Section 6.

Tier	Price	Includes
Free	No charge	Limited access to selected briefings and lessons. No payment method required.
Monthly	\$10.15 per month	Full access to the content library and paid features. Billed monthly in advance.
Annual	\$100.15 per year	Full access to the content library and paid features. Billed annually in advance at a discount versus monthly.

Final pricing, included features, and any team or enterprise options are presented at the point of purchase within the app and on [vantage15.com](#). The descriptions above are summaries and do not override the plan details shown at checkout.

2. FREE TRIAL

New paid subscriptions may include a 3-day free trial. The trial gives access to paid features at no charge for the trial period. To start a trial you may be required to provide a valid payment method.

Unless you cancel before the end of the 3-day trial, your subscription automatically converts to a paid subscription at the start of the first billing cycle, and your payment method is charged the applicable monthly or annual price. You may cancel at any time during the trial to avoid being charged. One trial is available per user. We may modify or withdraw trial offers at any time.

3. BILLING AND PAYMENT

Paid subscriptions are billed in advance through our payment processor, Stripe. By starting a trial or purchasing a subscription, you authorize us, through Stripe, to charge your selected payment method for the applicable subscription price, plus any applicable taxes, on a recurring basis until you cancel.

- Monthly subscriptions are billed once per month on the monthly renewal date.
- Annual subscriptions are billed once per year on the annual renewal date.

If a charge fails, we may retry the charge and may suspend access to paid features until payment is successfully processed. You are responsible for keeping your payment method current. We do not store full payment card numbers on our own infrastructure; payment data is handled by Stripe.

4. AUTOMATIC RENEWAL

Subscriptions renew automatically. A monthly subscription renews each month, and an annual subscription renews each year, at the then-current price for the same plan, unless you cancel before the renewal date. By subscribing, you consent to automatic recurring billing until cancellation. We will provide advance notice of any upcoming renewal as required by applicable law, including pre-renewal notice requirements under state auto-renewal laws.

5. CANCELLATION

You may cancel your subscription at any time through your account settings or by contacting support@vantage15.com. Deleting the App from your device does not cancel your subscription. Closing your account does not automatically cancel your subscription. You must cancel your subscription before deleting your account or removing the App to avoid future charges.

When you cancel, the following applies:

- Monthly subscription: Your subscription remains active through the end of the current billing month. After that date it does not renew, and access to paid features stops.
- Annual subscription: Your subscription remains active through the end of the current annual term. After that date it does not renew, and access to paid features stops.

Cancellation stops future renewals. It does not trigger a partial-period or prorated refund for the remainder of a term already paid. After cancellation takes effect, your account reverts to the free tier.

6. PRICE CHANGES

We may change subscription prices and the features included in each tier. Any price change applies to the next billing cycle after notice is provided, and where required by law, we will obtain your consent before the change takes effect. If features are removed from a paid tier mid-term, we do not provide partial refunds or credits unless required by applicable law.

If you do not agree to a price change, you may cancel before it takes effect. Continued use after a price change takes effect constitutes acceptance of the new price.

7. REFUNDS

Except where required by applicable law, subscription fees are non-refundable, and we do not provide refunds or credits for partial billing periods, unused access, or periods remaining after cancellation. Specific consumer rights that cannot be waived under your local law are not affected by this section.

EU Users: If you are an EU resident, you have the right to withdraw from a digital content purchase within 14 days of the agreement date without charge and without giving any reason. This right does not apply once digital content delivery has begun with your prior express consent and acknowledgment that you thereby lose your withdrawal right. BY COMPLETING A PURCHASE, YOU EXPRESSLY CONSENT TO IMMEDIATE DELIVERY OF DIGITAL CONTENT AND ACKNOWLEDGE THAT YOU LOSE YOUR RIGHT OF WITHDRAWAL ONCE DELIVERY BEGINS.

8. TAXES

Subscription prices may be exclusive of applicable taxes. Where we are required to collect sales, use, value-added, or similar taxes, those amounts will be added to your charge and processed through Stripe.

9. CHANGES TO THESE SUBSCRIPTION TERMS

We may update these Subscription Terms from time to time. When we make material changes, we will update the effective date above and, where appropriate, provide notice within the app. Continued use of the service after changes take effect constitutes acceptance of the revised Subscription Terms.
